DPhil in Population Health

About the course

The DPhil in Population Health is intended to provide you with training in research, an in-depth knowledge and understanding of your research topic and to prepare you for a career in academic research.

Applicants are strongly advised to visit the Medical Sciences Graduate School website to help them identify the most suitable course and supervisors.

Structure, content and assessment

You are admitted to the status of Probationer Research Student (PRS) in the first instance and you will then seek transfer to DPhil status by the end of your fourth term of admission. The confirmation of status will usually be carried out in the eighth term of admission as a research student, and no later than the ninth term. Both transfer and confirmation of status will require an oral assessment. Having successfully confirmed your status you will then be able to apply for examiners and submit your thesis for the viva.

Part-time study

A small number of part-time students may be admitted to the DPhil in Population Health. Candidates applying for admission to this part-time course are required to show that their DPhil research topic is suited to part-time study and the supervisor agrees with the part-time schedule.

The attendance requirement will be a minimum of 30 days University-based work per year. This will be spread across the academic year to be a minimum of ten days based in the department each term.

However, attendance is likely to be higher and will be determined by the demands of the individual DPhil research project and will be agreed with the candidate at interview.

Pattern of teaching, learning and supervision

Research training will primarily be through day-to-day involvement in a research project and working with a research team. The supervisor(s) will be the main source of your research training; you will also be encouraged to strengthen your research skills by taking relevant taught courses. Research training will be within a multidisciplinary research environment which includes epidemiology, statistics, ethics, health economics, health promotion, health services research, law and medical information data linkage systems.

You will be encouraged to make use of the range of skills trainings offered by the Medical Sciences Division through your study at Nuffield Department of Population Health (NDPH). These include statistics, data management, research ethics, writing academic papers and presentation skills. You are also expected to identify additional relevant courses that will support your research training.



Changes to courses

The University will seek to deliver each course in accordance with the descriptions set out above. However, there may be situations in which it is desirable or necessary for the University to make changes in course provision, either before or after registration. Tuition and college fees are payable each year for the duration of your fee liability (your fee liability is the length of time for which you are required to pay tuition and college fees).

Graduate students who have reached the end of their standard period of fee liability may be required to pay a termly University and/or college continuation charge.

The University continuation charge, per term for entry in 2016/17, is currently £440, please be aware that this will increase annually.

For part-time students, the termly charge will be half of the termly rate payable by full-time students.

If a college continuation charge applies (not applicable to non-matriculated courses) it is likely to be in the region of £100 to £400 per term. Please contact your college for more details.

Additional cost information

Full-time study

There are no compulsory elements of this programme that entail additional costs beyond fees and living costs. However, please note that, depending on your choice of research topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Part-time study

Please note that this course requires that you attend in Oxford for teaching, and you may incur additional travel and accommodation expenses for this. Further, as part of your course requirements, you may need to choose a dissertation, a project or a thesis topic. Depending on your choice of topic and the research required to complete it, you may incur additional expenses, such as travel expenses, research expenses, and field trips. You will need to meet these additional costs, although you may be able to apply for small grants from your department and/or college to help you cover some of these expenses.

Living costs

In addition to your fees, you will need to ensure that you have adequate funds to support your living costs for the duration of your course.
